Charge of Review is to reman and recommend appropriately as cause to appropriate Supervisor of employee, Ethical Complaint if Elected Official, and a breach recommendation to an agreement if agent. Said consideration before Review shall include direct actions under scope of service; public comments and actions where City of Marietta nexus is evident. Reference to accountability of this Section 1.11 shall be referenced in all agreements of whatever nature including individuals and entities.
