

(11) Council Bill #50974, Ordinance #3095, Amending the Code of Ordinances, Chapter 2, Article IV, Division 1, by adding Section 2-76, providing for employee benefits.

Councilman Cummins stated the proposed ordinance was in addition to the Pension Committee which did not deal with all employee benefits, i.e., health, holidays, vacation, sick leave, use of City vehicles, parking, etc.

Upon motion of Councilman Cummins, seconded by Councilman Garriss, it was moved and carried to amend Section 1 of the bill to read as follows:

"The Council for the City of Marietta shall review the employees benefit plan currently set forth in Ordinance #3042, dated September 30, 1973, or any other employee benefit plan hereafter adopted by the City Council at least once every twelve (12) months."

The vote to amend the ordinance as follows: "For" - Councilmen Cummins, Garriss, Brannen, Peek. "Opposed" - Councilmen Fields, Read.

Upon motion of Councilman Cummins, seconded by Councilman Garriss, it was moved and carried to approve the ordinance as amended.

The City Manager suggested if Council desired, the motion be amended that the review become a part of the budget consideration.

Councilman Cummins stated he would not object to same with the understanding the review to take place during six-month intervals.

The vote as follows: "For" - Councilman Cummins, Garriss, Peek, Fields, Read. "Abstaining" - Councilman Brannen.

COUNCIL BILL NO. 50974

ORDINANCE NO. 3095

AN ORDINANCE

AMENDING the Code of Ordinances of the City of Marietta, Georgia, Chapter 2, by adding thereto the following Section to be numbered Section 2-76, Providing for Employee Benefits.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MARIETTA, GEORGIA, THAT:

Section 1. The Council for the City of Marietta shall review the employee benefit plan currently set forth in Ordinance Number 3042, dated September 30, 1973, or any other employee benefit plan hereafter adopted by the City Council at least once every twelve (12) months, the review to become a part of budget consideration during six (6) month intervals.

Section 2. All ordinances or resolutions, or parts of ordinances or resolutions, insofar as they are inconsistent herewith, are hereby repealed.

Section 3. It is hereby declared to be the intention of the municipality that the sections, paragraphs, sentences, clauses, and phrases of this ordinance are severable, and if any phrase, clause, sentence, paragraph, or section of this ordinance shall be declared unconstitutional or otherwise invalid by the valid judgment or decree of a court of competent jurisdiction, such unconstitutionality or invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, and sections of this ordinance.

Section 4. This ordinance shall be in full force and effect after its passage and approval.
