## **INSPECTIONS**

Certain location set ups will require an inspection by the Marietta Fire Marshal's Office (FMO) prior to the use of the set up. Inspections include but are not limited to tents, food truck locations, and generators. Inspections must be coordinated with the FMO Special Events team.

## **FIRE SAFETY OFFICER REQUIREMENTS**

A Fire Safety Officer (FSO) will be required for certain special effects (flame effects, pyrotechnics), fire protection or life safety system being out of service or bypassed, where requested by production, or when required by the Fire Marshal or his or her designee. A FSO may also be required for special circumstances such as a production set up or special effect not meeting the prescriptive codes or standards

At a minimum the FSO must be a certified fire inspector with the State of Georgia and be employed with Authority Having Jurisdiction. The FSO minimum rate is \$75 per hour for a minimum of four (4) hours. The rate is subject to change due to staffing levels, holidays, or expedited request. Any request for FSO less than five (5) business days will be considered an expedited request.
