Foster Care (Lodging):

The requirements for 3 or less clients are:

1. Completed "Residential Care" form by the owner. No other requirements.

The requirements for 4 – 16 clients are:

1. Site Plan showing fire hydrant location with distance from the structure to the hydrant
2. Fire hydrant flow test Minimum 1500 gpm @ 20 psi: to schedule a water flow test visit the Marietta Water Website at www.MariettaGA.gov.
3. Full fire alarm system (pull station at each exit)
4. Fire extinguisher (minimum 2A10BC)
5. Smoke detectors in all bedrooms, hardwired with battery back-up.
6. Window size meets 5.7 square feet for sleeping areas (see exceptions)
7. 2 means of egress (see exceptions)

Personal Care Home (Board & Care):

The requirements for 3 or less clients are:

1. Evacuation plan posted
2. Fire extinguisher (Minimum 2A10BC)
3. Rechargeable light (flashlight type)
4. Smoke detectors (hardwired) with battery back up.
5. Operable window in sleeping rooms

The requirements for 4 – 6 clients are:

1. Site Plan showing fire hydrant location with distance from the structure to the hydrant
2. Fire hydrant flow test – Minimum 1500 gpm @ 20 psi: to schedule a water flow test visit the Marietta Water Website at www.MariettaGA.gov.
3. Full fire alarm system (pull station at each exit).
4. Fire extinguisher (Minimum 2A10BC)
5. Window size meets 5.7 square feet for sleeping areas.
6. Smoke detectors in bedrooms, hardwired with battery back-up.
7. Living areas and hallway smoke detectors connected to alarm system.
8. Fire sprinkler system required.
9. Copy of state license (when issued)

These lists of requirements are NOT all inclusive. The above requirements are only to advise you of the major differences in these types of occupancies. An on-site inspection may reveal discrepancies that will need to be addressed before a release will be issued.
