The Training Division is responsible for ensuring the professional competence of all emergency responders within the Marietta Fire Department. By combining classroom and live training, the division prepares our department for a wide range of emergencies.



The Suppression Division is called upon to mitigate emergencies ranging from basic to advanced life support. These men and women also respond to structure fires, vehicle fires, technical rescues, and hazardous material situations. The job requirements for a firefighter are extensive and often dangerous. Therefore, top priority is placed on firefighters maintaining physical fitness so that dangerous jobs can be accomplished as safely as possible.

The Suppression Division also spent numerous hours performing hydrant inspections, business inspections, pre-plans and pressure testing fire hose to ensure preparedness for when an emergency arises.



Working together with the Suppression Division, the Prevention Division is better able to serve the constantly growing need of our community.

Intense and skill specific training allows proper preparation for us to serve the community safely and more efficiently.

The Training Division also conducted a recruit class that resulted in eight probationary firefighters being placed on duty this year.
