20081221 V2008-21 Marietta Recycling Center 303 Marble Mill Road

V2008-21 MARIETTA RECYCLING CENTER requests variance for property located in Land Lot 1005, 16th District, Parcel 0320, 2nd Section of Cobb County, Marietta, Georgia and being located at 303 Marble Mill Road. Variance to increase the allowable height for a fence or wall from 8 feet to 12 feet. Ward 5.

20081222 V2008-22 Sin Lee 1585 Roswell Road

V2008-22 SIN LEE request variances for property located in Land Lot 12080, 16th District, Parcel 0710, 2nd Section of Cobb County, Marietta, Georgia and being located at 1585 Roswell Road. Variance to allow temporary structure to remain as a permanent structure; variance to allow accessory structure in front yard; variance to reduce front yard setback and variance to reduce the required side yard setback. Variance to raise the maximum building height by 8' for the sign tower only; variance to allow wall signs to be located on tower structure above parapet wall; variance to allow wall

signs to be located on the east and west tower wall faces that do not abut a public roadway; approval to allow stucco EIFS to be installed over block for parapet, cornice and window arch; first and second floor in front of the building only, not to exceed 30% of the building elevation; and approval of revised architectural rendering.
